He graduated in Medicine and specialized in Hygiene and Preventive Medicine at the University of Naples “Federico II”. He obtained a Master of Science in Epidemiology and subsequently he became Doctor of Science in Epidemiology at the Erasmus University of Rotterdam, the Netherlands. Professor La Torre authored 613 publications in peer-reviewed journals. He wrote a number of health technology assessment reports on drugs, vaccines, and medical devices.

Ceri Phillips was Professor of Health Economics at Swansea University Centre for Health Economics and Head of Research at the College of Human and

Up until November 2011 he was the health economics member of the All Wales Medicines Strategy Group (AWMSG), which advises the Welsh Minister of Health and Social Services on matters relating to prescribing decisions and medicines management, and was the Vice Chair of its New Medicines Group, which appraises all eligible new, licensed medicines, available for use in the NHS, and which makes recommendations to AWMSG. He has undertaken commissioned work on the evaluation of programs and interventions for a range of organizations, including the World Health Organization, Welsh Government, Department of Health, Department of Work and Pensions and a range of health and social care authorities and pharmaceutical companies. He has published extensively in the field of health economics, health and social policy, with over 230 books and journal articles.

Lorenzo Pradelli is medical director at AdRes Health Economics and Outcomes Research srl, Torino, Italy. He is in charge of the design, development and management of pharmacoeconomic researches, with particular reference to the medical and scientific aspects. He has been the recipient of numerous international awards such as a Scheele Laureate from the Swedish Academy of Pharmaceutical Sciences, Fellowship in the Mexican Academy of Pharmaceutical Sciences, the André Bédard Award from the International Pharmacy Federation (FIP), research achievement award from the American Pharmacists Association, and Fellowship from the American Association of Pharmaceutical Scientists.
